

ISO 29993 and ISO 21001

Standards for education providers

MOTIVATION AND BENEFITS

The two standards ISO 29993 and ISO 21001 are standards specially created for educational organizations and thus supplement the range of different approaches to the topic of standards in the educational sector.

This enables organizations providing training and further training to choose among different standards. Depending on the objectives and requirements, the system fitting best can be used.

The standards address any types of educational institutions imparting knowledge to learners, e.g. by giving lessons, providing practice oriented training, holding playful teaching units in the kindergarten or being involved in research projects. No matter what the education service is like, endeavours to support the learners in acquiring competencies are in the centre of interest.

Institutions providing formal education (e.g. schools or universities) do not belong to the immediate target group. However, utilisation of the standards can be very useful for the further development of the respective organisation and the services offered by this organisation.

ISO 29993

The focus of ISO 29993 is on the service processes and the range of services. The standard defines a generic reference framework for education services by specifying the different elements and their implementation. This covers any types of education services, including the forms of lifelong learning (e.g. vocational training and in-company training, which may be external or internal). The standard encompasses all learning methods and techniques: face-to-face, e-learning or a combination thereof (blended learning).

TARGET GROUP

Any educational institutions, which range from the personal tutor via private seminar and course providers and in-company training and further training to academies and higher-education institutions that want to focus on the education service.

ISO 21001

ISO 21001 has been adapted to the structure of ISO 9001 and thus follows the present trend for harmonization in the sense of the High Level Structure. As far as the contents are concerned, ISO 21001 clearly focuses on the needs of the learners and other interested parties as well as beneficiaries of the service. As far as the topics and terms and concepts are concerned, ISO 21001 focuses on the topics relevant to educational institutions, no matter what the education service is like. The standard also includes hints facilitating practical implementation. ISO 21001 is a standard covering a very wide range of target groups, namely the kindergarten, post-doctoral education and lifelong learning, including vocational training, as well as any types of learning methods, such as distance learning.
